NEGOTIATION UPDATE

On 22 October 2022, Ngāti Hāua signed an Agreement in Principle (AIP) – Te Whiringa Muka - with the Crown to settle Ngāti Hāua’s historical Treaty of Waitangi claims. While we have experienced some setbacks and delays in getting to this significant milestone, the signing was both a celebration of our collective efforts and moemoea, as well as a time to reflect upon the many we have lost, and their hard work and dedication to the Kaupapa.

Te Whiringa Muka includes a broad range of financial, cultural and social redress for Ngāti Hāua, with a current financial value of \$23 million and the return of many sites of significance to the Iwi. In the months ahead, we are determined to negotiate for further increases in our Treaty settlement package and we will also hold a series of wānanga on the “House of Hāua” to ensure that any future settlement for Ngāti Hāua is firmly grounded upon a strong and enduring collective cultural foundation. We are now working hard towards initialing our Deed of Settlement over the next 12-24 months. Once the Deed is initialed, we will bring it back to the Iwi to discuss and debate. All registered adult uri will then be able to vote to decide whether to accept the Deed of Settlement. In the coming months we will also need to determine the design and structure of our future Ngāti Hāua Post Settlement Governance Entity (PSGE), which will be responsible for managing and growing our Treaty settlement assets, as well as enhancing the wellbeing of all uri and our taiao. This is an important and exciting time for Ngāti Hāua.

Te Whare Taumarutanga

The Overarching Shelter

Prevention, Protection & Response for
Covid-19

The iwi of Ngāti Hāua, Ngāti Tūwharetoa and Ngāti Maniapoto united to establish a collective response for the community of Taumarunui to the Covid-19 Pandemic, back in November 2021.

Te Taumarutanga continues to provide information for Covid-19 testing, vaccination, isolation and strong health advocacy. It formed the Iwi response for holistic care in preparation for Covid + cases to ensure that our whānau get the support and ongoing care they need to fight this ngāngara.

The response was jointly created by Maxine Ketu, Ngāti Hāua; Channey Iwikau, Ngāti Tūwharetoa; Arthur Tane, Ngāti Maniapoto through hui with whānau, hapū and Iwi within the catchment of Taumarunui.

Te Whare Taumarutanga – The Overarching Shelter – is the underpinning framework created by Rangi-Te-Pō Whatarangi and Piki Taiaroa which puts Māori at the heart of Taumarunui's Covid-19 response narrative. It also acknowledges the history of the three Iwi and responds to their needs through aroha and manaakitanga.

Fifteen months later, in collaboration with community groups and support, our hāpori has achieved first vaccination rates around 84%. This has been a fantastic effort and result. This success has resulted in many of the team moving on and being supported into either employment, education or training.

Our current team remain committed and continue to advocate health equity.
